Treasurer Kinnaman gave the Treasurer's Report and Vice Chair Houston gave the Budget and Finance Report.

Chair Vala assigned Commissioner Haley to the Economic Development and Community Affairs Committee, and Commissioner Franke to the Public Safety and Military Affairs Committee.

Chair Vala gave the construction report.

Commissioner Hardwick reported a 26.94% increase in year-to-date passenger activity compared to last year.

Commissioner Hardwick reported that fuel sales for the month of July were 129,559 gallons with revenue of \$16,327. Airline gallons were up with the reinstated (COVID-19 recovery) evening departure for United Airlines. Retail Jet fuel sales remained steady compared to the previous month. Avgas sales rose sharply with the continuing operation of the aerial survey teams operating from the Stellar Aviation facilities.

Executive Director Hanna reported meeting with numerous airlines at an air service development conference. Mr. Hanna reported that Allegiant will begin a new route to Mesa/Phoenix on November 18<sup>th</sup> with twice weekly flights.

Commissioner Houston made a motion to adjourn, seconded by Commissioner Haley and carried with a vote of ayes.
